Welcome to Salt Lake County Drug Court. This court is not like any other court you have been in. It is very different. Look around at the people in the courtroom. Every person on the court team is a treatment professional. This includes the Judge, District Attorney, Public Defender, caseworkers and the Probation officers, in addition to the staff from Criminal Justice Services. Some of them, like the Judge, are nationally recognized experts in assisting criminally involved drug offenders. ALL of them have had special training to assist you.

This court uses a modified Drug Court model. That means we spend more time on your treatment and on your case than a standard court process. It means that we expect you to be our partner in this process. You will work very hard, and we expect you to.

The court team meets and discusses your case before it is called in open court. When you do good work and are working your program, we will recognize your hard work and congratulate you. When you do not, we will do two things: address the violation of the court's orders and work with you to assist with your treatment needs.

Getting off of drugs is hard work. We know that. Everyone in the courtroom is committed to working with you to support your hard work. Getting off drugs will take all of your energy and will. We will help you. There are specific rules for this court. Listen to them carefully. Read them often. Have your family and sober friends read them. They can help you.

In this court, we have already seen miracles happen, just as we have over hundreds of times in the Salt Lake Drug Court. People who have used drugs and alcohol for 20 or more years have become clean and sober, gotten their GED and have become employed. You can do it, too. We do not care if you have been to prison, or if you have failed treatment before. If you follow our program and work as hard as you can, we think you can succeed.

If you want to get off drugs and gain a healthy life, you have come to the right place.

Please respect the court process, remain quiet in court. Other people are speaking with the Judge or their attorney. They may be getting praise or help. You will expect the same courtesy when it is your turn. Listen to the court process, and learn. There is a great deal to learn just sitting there.

Being late for court, your appointments, or your treatment group is not acceptable. It is rude to everyone who participates in this program. Missing court, treatment, or a meeting with your probation officer can result in your arrest, the filing of a violation of probation or termination from the program.

Dress appropriately for court. Part of the training you receive is job skills. Bathing, cleaning and wearing clean appropriate clothes are job skills. Do NOT wear shirts or jackets with drug, alcohol or vulgar sayings on them. It is disrespectful to others who are trying to remain sober. Do NOT wear hats into the courtroom. If you have problems with clothing or other personal needs, tell your treatment team or probation officer. Sometimes we can help.

What to expect

This treatment program is built on accountability and respect.

Your caseworker and treatment team are going to review the program in detail. You should expect to be assessed and screened for the level of treatment and supervision which you need. You will be sent to treatment almost immediately. We will monitor your attendance and progress in treatment.

You will be drug-tested often and on a random basis. Your drug-testing will be done by both CJS and some treatment providers and Adult Probation and Parole if applicable. You will have visits by probation and the police at your home pursuant to the Court's orders.

For some of you, this will be a full time job. Court moves very fast. If you have questions about what happened, talk to your caseworker or your attorney. If you have questions about the orders of the Court, it is important that you talk to your probation officer. We want you to be a part of the process and to participate in your treatment plan. We provide the help; you will be doing the hard work necessary to stay clean and sober.

You will be drug-tested and held accountable for the test results.

Comprehensive Treatment Court

We are a no-nonsense team dedicated to helping you get off of drugs. We demand honesty, and accountability. We demand you try as hard as you can. We recognize the amazing courage and strength it takes to stop using drugs. We will work to reward you for your hard work, and address your failures in a fair and consistent manner. If you have a problem, tell your caseworker. If you are going to test dirty, tell your caseworker or the person supervising the test BEFORE the test. If you have relapsed, let us know so we can provide additional treatment responses for you. If you are having other problems that cause you discomfort or concern, you need to tell your treatment team. If you have good news, tell your treatment team. We love to hear good news, and can share it with the Judge. This team likes to acknowledge your good work, and to share your good news. We believe in you, and care what happens to you. In this court, we try to treat everyone in a fair manner. Because people are different, and they have different challenges to their sobriety, sometimes our response is not the SAME, but it is FAIR.

Sanctions and Incentives

The Court uses sanctions and incentives to assist you with your program. Examples of sanctions include being ordered to perform community service or writing an essay, or some other assignment which gets your attention on what the court team needs you to do. Incentives include praise, clapping, recognition in the court for your fine work, or a change in the level of work that you need to do as you progress on your treatment plan.

You will be drug-tested often. This is done to assist you with your sobriety. You should always assume that you could be tested at any moment. All testing is personally observed. We want you to work an honest program. If you are dirty, or relapse, we can help you. Amazing as it is, the people who fail from Drug Court tell us that they wished we had tested them more. Drug Court is

focused on your success. If you come here to just get by or do time, change your viewpoint. We use sanctions and incentives to help you move through recovery.

Be honest.

Ask for help when you need it.

Ask if you don't understand everything.

Be on time for everything.

Be responsible.

Be clean and dress appropriately.

No drugs, no alcohol, no crimes.

Don't take any prescription drugs unless you get the permission of your caseworker FIRST! We can give you a letter for your doctor.

Avoid the people, places and things which threaten your recovery, and your freedom.

Call your caseworker for help.

Talk to your lawyer for help.

Make every group session and meeting count.

Get a sponsor and attend AA/NA or 12 step recovery.

If there are drugs, alcohol, weapons in your house or car, get rid of them. You will be visited by law enforcement. You will be searched. We are very serious about your recovery and do not want any people, places or things around you which might threaten your chances of success. Report contact with law enforcement to your caseworker within 48 hours.
